## **AUDIT SUMMARY**

#### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

#### About the audit

This report contains the results of our independent accountability audit of Public Utility District No. 1 of Klickitat County from January 1, 2013 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Billing, receipting and collections
- Use of bond proceeds
- Procurement and day labor
- Citizen hotline use of Low-Income Housing Energy Assistance Program payments
- Operation Warm Heart
- General disbursements
- Payroll disbursements
- Sale of surplus property

## **Financial**

A financial statement audit was performed by a firm of certified public accountants. That firm's report is available from Public Utility District No. 1 of Klickitat County.

## INFORMATION ABOUT THE DISTRICT

Public Utility District No. 1 of Klickitat County consists of an electric system, eight water systems and five wastewater systems. The District also operates two additional water and wastewater systems that are owned by other public entities. As of December 31, 2013, the District had 12,324 electric, 1,124 water and 1,187 wastewater customers.

An elected, three-member Board of Commissioners governs the District. The Board appoints management to oversee the District's operations as well as its approximately 85 employees. For 2013, the District had annual operating revenue in excess of \$41 million, primarily from the operation of the electric system.
