# Klickitat PUD Elects New Officers

The election of officers took place at the Klickitat PUD Board of Commissioners' meeting December 10, 2013, and became effective January 1, 2014.

The results were:

President—Dan G. Gunkel

Vice president—Ray A. Mosbrucker

Secretary—Randy L. Knowles Public Utility District No. 1 of Klickitat

County is governed by a three-member board of commissioners elected by the citizens of Klickitat County. Each commissioner represents a different district of the county and serves a six-year term. The commissioners also represent Klickitat PUD as delegates to various business organizations, including the Washington PUD Association, the Public Power Council and Northwest Public Power Association. The commission terms are staggered so that a different commissioner runs for re-election every

Commission meetings are at 2 p.m. on the second and fourth Tuesday of each month in the Klickitat PUD Board Room at 1313 S. Columbus Ave. in Goldendale. Special meetings and workshops are called by the commission as the need arises, and are advertised in the local newspapers under legal notices.

# Dan G. Gunkel, President

Dan Gunkel was first elected as a Klickitat PUD commissioner in December 1990 and is serving in his fourth term.

Dan was appointed to Energy Northwest's Board of Directors in 1991, and has served on its executive board since June 1994, serving as vice chairman from 2003 to 2006. Dan also was appointed chairman of Energy

Northwest's operations, construction and safety committee in 2006.

Dan has been a resident of Klickitat County his entire life. He is a co-owner of Gunkel Orchards, responsible for shipping and marketing produce.

Dan's District 3 term expires December 2014.

## Ray A. Mosbrucker, Vice President

Ray Mosbrucker was first elected to the Board of Commissioners in December 2004. He is serving his second term on the board.

Ray is a lifelong resident of Klickitat County, owns several businesses in the Goldendale area and is working toward semi-retirement. He has a broad knowledge of the electrical and construction business and expertise in economic development. Ray is involved at many levels, including the state legislature, to ensure the needs and requirements of public utilities are met.

Ray's District 2 term expires December 2016.

# Randy L. Knowles, Secretary

Randy Knowles was re-elected in 2012 for his fourth term as PUD commissioner. He was first elected to the Board of Commissioners in December 1994.

Randy is a lifelong resident of Klickitat County's west end. Although he considers himself semi-retired, he manages a variety of business ventures and his entrepreneur attitude has contributed to the PUD's growth. A logger by trade, he still deals in timberland and occasionally heads to the woods to do some logging.

Randy's District 1 term expires December 2018. ■
