AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of Public Utility District No. 1 of Klickitat County from January 1, 2021 through December 31, 2021.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended December 31, 2021, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts receivable – utilities
- Payroll – gross wage, leave cash outs, and electronic funds transfers
- Cash receipting –timeliness and completeness of deposits and voids and adjustments
- Accounts payable – general disbursements and electronic funds transfers
- Procurement – public works
- Self-insurance for unemployment
- Open public meetings – compliance with minutes, meetings and executive session requirements
- Financial condition – reviewing for indications of financial distress

Finding Caption: The District lacked adequate controls in place for ensuring compliance with state procurement laws.		
Background: State law requires the District to perform responsible bidder checks prior to awarding a contract for a public works project. These checks are designed to ensure contractors are properly licensed and registered with the state, have liability insurance, pay workers' compensation to the state, pay prevailing wages, and are not prohibited from working on state contracts. The Legislature added a new responsible bidder requirement to state law effective July 2017, which requires governments to obtain a signed statement from the bidder certifying its compliance with established criteria to be considered a responsible bidder. In 2020, the District did not ensure it updated its policies and procedures to include the additional requirement when conducting responsible bidder checks for contracts related to the District's construction projects.

INFORMATION ABOUT THE DISTRICT

Public Utility District No. 1 of Klickitat County (the District) consists of the electric system, nine water systems, and five wastewater systems. The District also operates an additional water and wastewater system that are owned by other public entities. The District's service area covers approximately 1,680 square miles in Klickitat County. The District also serves small areas in the surrounding counties of Yakima, Skamania, and Benton. As of December 31, 2021, the District had 13,884 electric, 1,230 water and 1,274 wastewater customers.

An elected, three-member Board of Commissioners governs the District. The Board appoints management to oversee the District's operations as well as its approximately 90 employees. For 2021, the District had annual operating revenue of approximately \$62.5 million, mostly from the operation of the electric system.
