CONNECTION FEE DEFINITIONS

Water Meter Connection: Applies only to lots with an existing empty meter box and service line to main. Connect meter only in existing meter box. Water Service Connection: Standard 3/4" meter connected up to 10 ft.from main

Sewer Inspection: Applies only to lots with an existing cleanout and service line to main. Inspect customer line after construction.

Sewer Service: Locate sewer main and inspect customer line after construction. Non-standard Connections: All connections that do not meet the criteria for standard connections will be based on estimated cost to connect.
