GENERAL MANAGER'S REPORT TO THE BOARD For the October 11, 2022 Meeting

AGENDA ITEMS:

- A. Resolution # 1825 Low Income and Elderly Discount Brandy Myers is requesting approval of Resolution 1825. The proposed updates align the income thresholds with the 2022 Federal Poverty guidelines. Klickitat County Senior Services will administer the application process and bring back the application approvals. This year Klickitat PUD is coordinating with WGAP and KCSS to promote program participation at meal site visits beginning October 18.

- 2. <u>Glenwood Water Right Application</u> We received a message from tribal staff processing the application. They are wrapping up the permit and determining annual fees. We do not have a timeline at this time.
