GENERAL MANAGER'S REPORT TO THE BOARD

For the October 25, 2022 Meeting

AGENDA ITEMS:

- A. Washington Public Utility District Association 2022 Scholarship Nomination Mike DeMott, Brandy Myers and Mike Nixon reviewed the two applications. Thea Smith, daughter of Jim Smith, and Kali Watson, daughter of Greg Watson, submitted applications. After reviewing and scoring the applications, the committee came to the decision that Thea Smith would be their recommendation for the nomination. Gwyn Miller will be requesting a motion to submit Thea Smith's application to WPUDA as KPUD's nominee.
- B. Review of 2023 Budgets and Financials Staff will present at the meeting a high-level view of the expense, labor and capital budgets for 2023. We will also present a draft of the 2023 financials.

NON-AGENDA ITEMS:

- 1. <u>Public Generating Pool (PGP)</u> Although we are not renewing our membership with PGP for 2023, I was asked to participate in the strategic planning session on October 19 20.

- 5. <u>RNG Tax Audit update</u> General Council has recommended and will file for the 30-day extension to appeal the tax audit assessment.
