GENERAL MANAGER'S REPORT TO THE BOARD

For the December 23, 2024 Meeting

AGENDA ITEMS:

- A. 2025 Bucket Truck Purchase Order Approval April Castillo will present the request for purchase order approval for Mike Nixon. April is requesting that the board authorize the Operations Manager to order the Ford F550 w/ Altec AT40G Manlift vehicles slated under the 2025 budget. Per Procedure 27, purchases of materials, equipment or supplies exceeding \$120,000.00 will be approved and awarded by the District's Board of Commissioners. In previous years, we have waited to order vehicles from the state bid until the budget year begins which has resulted in vehicle capital outlay outside of the approved budget year. Through Sourcewell, the vehicle delivery isapproximately twelve months. If ordered now, we expect delivery mid-December.
- B. <u>Resolution 1868 Surplus a portion of the Satus Pass Distribution Line</u> This action would take place after approval of the motion regarding this line, listed below.

1. Satus Pass distribution line - I will be asking the board for a motion to:

"Declare the intent to stop providing service to customers served by the portion of the Satus Pass distribution line north of pole number 3923-1507.9 by June 1, 2025."

The portion of line at issue starts at the southern edge of the Yakama Reservation and extends north to the end of the line. I am talking specifically about the portion of line that resides on the Yakama Reservation, which is located on expired ROWs that we have not been able to renew and that serves locations that are outside of the PUD's county service territory. This line does not serve customers located within our Klickitat County service territory. There are insufficient customers to cover the cost of maintaining the line. Removing this portion of the line will result in lower liability risks to Klickitat County PUD and the customers within its service territory. I am asking that you declare the intent to no longer serve this area.
