CALL TO ORDER: President Randy L. Knowles called the meeting to order at 2:00 p.m. as advertised.

MINUTES: MOTION was made by Commissioner Gunkel to approve the December 10, 2024 meeting minutes as presented. Motion carried.

ASSISTANT GENERAL MANAGER REPORT - Gwyn Miller presented:

• Request to approve cost of living adjustment - Staff recommends a cost of living adjustment of 4.75% as included within the approved 2025 Operating

Budget. **MOTION** was made by Commissioner Gunkel to authorize the General Manager to execute a 4.75% cost of living adjustment as recommended by staff. Motion carried.

• Holiday Schedule - Gwyn informed the board that per policy the office closes Christmas Eve at 3:00p.m. and is closed Christmas day. Gwyn requested that the board approve closing the office at 3:00p.m. on New Year's Eve as well. Commissioner Miller inquired what the New Year's Eve schedule was. Per Policy New Year's Eve is a normal business day. MOTION was made by Commissioner Miller to approve a 3:00p.m. office closure December 31, 2024 and requested that staff bring back a policy update recognizing a permanent New Year's Eve revision. - <u>Satus Pass Distribution Line</u> After providing an update, **MOTION** was made by Commissioner Knowles to declare the intent to stop providing service to customers served by the portion of the Satus Pass distribution line north of pole number 3923-1507.9 by June 1, 2025. Motion carried.

- B. <u>RESOLUTION 1868 SURPLUS A PORTION OF THE SATUS PASS 12KV DISTRIBUTION LINE</u> **MOTION** was made by Commissioner Gunkel to adopt Resolution 1868 authorizing the Satus Pass distribution line north of pole no. 3923-1507.9 be declared surplus per RCW 54.16.180(2)(b) and hereby authorize the General Manager to sell or dispose of the distribution line through Klickitat PUD's normal procedures for selling and disposing of surplus property at his discretion and in the best interest of Klickitat County PUD. Motion carried.
- C.
