NON-AGENDA ITEMS:

- 1. I will be out of the office the week of July 25th, but I will doing several meetings and will be at the Commission meeting.
- 2. Customer Water Reservation we have received a request to complete a water reservation contract for 470 ac-ft of consumptive municipal water from the Cliffs Water System for a period of 5 years. Their potable water supply requirements are not large and we are not contemplating needing a reservation.
- 3. NCS Amended Water Supply and Settlement Agreement Athan drafted the notes that Scott Tillman and Commissioner Knowles reviewed into an amendment that aligns with our draft water supply agreements with FFP. That draft is with Scott Tillman for review.
- 4. Goldendale Energy Storage Project / Free Flow Power Contracts FFP is working with us to execute the Water Supply Agreement on August 1st. We will need to have the amendment mentioned about executed at the same time.
- 5. LFG Infrastructure Fund Applications we are completing drafts and we have a date of August 3rd for this meeting. County Commissioner Jacob Anderson is the County representative.
