

Residential Unitary Heat Pump Water Heater BPA Qualified Only

Rebate for qualifying units \$300.00

Participation Requirements:

This rebate is available for new and existing single-family homes and manufactures homes (Homes must be within the Klickitat PUD service territory). In existing homes, the HPWH must replace and electric storage water heater (gas does not qualify). The primary source of heat in the home must be electric with no connection to natural gas.

Unitary HPWH's must be on the current BPA Qualified products list and installed, according to manufacturer's specifications. They can be self-installed or the professional installer must have received training from the manufacturer, if available. **Split system HPWH may qualify for rebate. Contact KPUD for more details.

Customer will need to complete a Rebate Application, the Installation Form, and attach a copy of the original sales receipt with proof of make and model of each unit. Once received and approved request for payment will be processed.

Kickbacks, rebates, non-authorized discounting of bids or other non-program benefits from the Contractors are prohibited, and may be subject to federal law.

All materials and installations must comply with current KPUD/BPA conservation specifications in order to be eligible for funding.

Contractors, participating in the program shall not be considered officers, agents or employees of BPA or KPUD; therefore, KPUD shall not be liable for the tortuous acts or omissions of the Contractors or other independent contractors.

Privacy Notice:

Your interest in our conservation program is appreciated. We hope that you will decide to participate in these energy savings activities. If you do, it is necessary for you to provide some information to us, which will enable us to run this program successfully.

The information to be collected includes the names and addresses of customers participating in the program technical data about energy use and efficiency. We need this information to determine whether you are eligible for the program. Beyond this, the information collected will be used to evaluate and audit the conservation program.

Upon BPA's request, we will provide them with this information. BPA may also wish to make certain site visits to evaluate the installations and the performance of the program.

The data provided will then be used to assist us in developing new programs and in assessing energy savings obtained by existing programs in the region. This information will be retained for three years. It may be released to the public, but only in anonymous statistical form.
