Water Use Efficiency Rule

Growing communities, agriculture, industry, and the importance of conserving water have placed an increasing demand on our state's water resources. To help meet these growing needs, the Washington State Legislature passed the Municipal Water Law.

Water Quality Report

The 2018 Water Quality Report for 2017 is provided to all the residents of Ponderosa Park who are supplied with drinking water. This report is designed to inform you about water quality and services that are delivered to you every day. Our goal is to provide a safe, dependable water source to your community. The Klickitat County PUD is continually making efforts to improve our treatment processes and protect our water resources. Our Ponderosa Park water system is identified by a **Washington Department of Health identification number: 15571A.**

Health Information

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons, such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV, AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. Where does our water come from?

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Ponderosa Park water comes from groundwater. The source of water is from a well near the eastern edge of the community. Water is gravity fed from the reservoir through an underground distribution system, through a series of pressure regulating valves on the water mains, to the individual house water meters. The water is chlorinated twice a year at the reservoir to eliminate the potential for bacteria throughout the system. In 2014 a 126,900 gallon concrete reservoir was brought online and distribution lines along Golden Pine were updated.

KPUD Water Operators are diligently working to eliminate unaccounted water loss due to leaking valves and distribution lines throughout the water system.

Summit Excavation has been hired to replace the old water meters with new radio read meters.

Contaminants that may be present in source water before we treat it include:

Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic tanks, agricultural livestock operations and /or wildlife.
Inorganic contaminants, such as salts and metals, which can be naturally occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining and/or farming.

Pesticides and herbicides, may come from a variety of sources such as residential uses or agricultural practices.
Radioactive contaminants, which are naturally occurring.
Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff and septic systems.

Note: Only those contaminants that were actually detected are listed. All others were not found in your water source.

*These results are the most recent testing, done in accordance with regulations. Class A systems are only required to test for Inorganic Contaminants every three year reporting period. The water quality information presented in the table is from the most recent round of testing done according to the regulations. All data shown were collected during the last calendar year unless otherwise noted in the table.

+ Copper and Lead were analyzed from the source (directly from the well). Copper and Lead were below the action level.
 ~ The MCL & MCLG for Nickel were remanded on Feb. 2, 1995. This means that while many water suppliers continue to monitor nickel levels in their water, there is currently no EPA legal limit on the amount of nickel in drinking water.

Terms & Abbreviations used above:

Action Level (AL): the concentration of a contaminant which, when exceeded, triggers treatment or other requirements which a water system must follow.

Maximum Contaminant Level Goal (MCLG): the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Maximum Contaminant Level (MCL): the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Residual Disinfectant Level (MRDL): The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

Maximum Residual Disinfectant Level Goal (MRDLG): The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

Whether excavating with a shovel or a backhoe; if you are digging deeper than 12 inches you MUST first notify underground utility owners. If you DO NOT call and you hit a utility line it could cost you a lot of money, more importantly it could cost a life.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. KPUD is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for thirty seconds to two minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested.
